### 4. CODE OF CONDUCT:

You shall conform to the policies of MapleLabs at all times, as may be introduced from time to time and are required to maintain high standards of conduct and excellence in rendering your services to MapleLabs.

# **5. TERMINATION**

Your Internship is subject to the accuracy of the information, records and documents provided by you regarding your education. Should MapleLabs determine at any time that you have provided false or inaccurate information, or that you have withheld relevant information, MapleLabs reserves the right to terminate your Internship any time without prior notice. MapleLabs further reserves the right to terminate your Internship if your conduct is considered to be unbecoming or is considered to be detrimental to the interest of the MapleLabs. MapleLabs will be at liberty to terminate your Internship if your performance is found to be unsatisfactory at any time during the term of your Internship, without any prior notice.

You acknowledge and undertake not to divulge or utilize information relating to general business operations of MapleLabs (including information relating to research, design, development, manufacture and sale of products of MapleLabs), except with the prior written consent of MapleLabs. MapleLabs reserves the right to pursue strict disciplinary action, including initiating legal action, in the event of any violation of this Clause.
